- 3. The charge is dependent on the type of work that is carried out. Please see separate charges guidance. You may be eligible for a 'disabled persons' exemption.
- 4. Planning Permission maybe required for your project. Please confirm with Development Control prior to commencement.
- 5. Prior to starting work on site, two working days notice of commencement must be provided to the council.
- 6. Notice must be given to Norfolk County Council before any opening is made in the highway.
