#### **Additional considerations**

**100.1** Planning permission has been granted for 5000 new dwellings in Thetford (3PL/2011/0805/O). The outline application proposes approximately 19.2 ha of playing fields, 5.37 ha of allotments and 28 ha of open space.

**100.2** Application 3PL/2011/0805/O has confirmed that Gallows Hill Scheduled Monument has been identified for open space provision in accordance with Policy TH22 of the Thetford Area Action plan. Given its location, it is likely that the site will come forward in the later phases of development.




Figure 100.1 Thetford






Figure 100.2 Thetford 2




Picture 100.1 Thetford 3




Figure 100.3 Thetford 9




Figure 100.4 Thetford 10




Figure 100.5 Thetford 11




Figure 102.1 Tittleshall




Figure 103.1 Twyford




Figure 104.1 Watton - Map 1




Figure 104.2 Watton - Map 2




Figure 104.3 Watton - Map 3




Figure 104.4 Watton - Map 4




Figure 105.1 Weasenham





Figure 106.1 Weeting - Map 1




Figure 107.1 Wellingham




Figure 108.1 Wendling




Figure 109.1 Whinburgh





Picture 111.1 Wretham - Map 1





Figure 111.1 Wretham - Map 2




Figure 112.1 Yaxham
