Notice of consultation

I have previously written to advise you that Mattishall Parish Council is reviewing its Neighbourhood Plan. A Neighbourhood Plan allows a Parish Council to identify Local Green Spaces that have a particular significance for the Village, perhaps as a component of the village landscape, as a special site for wildlife, or for recreation, or simply to be appreciated as part of the view from a local footpath. There is no presumption of public access to sites on private ownership.

The National Planning Policy Framework 2021 (the NPPF) (available to view at https://www.gov.uk/government/publications/national-planning-policy-framework--2) specifies (see paragraph 102) that the Local Green Space designation should only be used where the green space is:

- a) in reasonably close proximity to the community it serves;
- b) demonstrably special to a local community and holds a particular local significance, for example because of its beauty, historic significance, recreational value (including as a playing field), tranquillity or richness of its wildlife; and
- c) local in character and not an extensive tract of land.

NPPF 2021, Paragraph 102

Would designation place any restrictions or obligations on landowners?

National planning practice guidance¹ states that "Designating a green area as Local Green Space would give it protection consistent with that in respect of Green Belt, but otherwise there are no new restrictions or obligations on landowners" Government planning practice Guidance: Paragraph: 020 Reference ID: 37-020-20140306

Are there any existing Local Green Space designations in Mattishall parish?

The current Mattishall Neighbourhood Plan already designates the playing field to the south of the primary school as a Local Green Space

What about Breckland's Local Plan?

Breckland District Council is currently undertaking a review of its Local Plan. As part of this process Breckland Council has requested suggestions of sites appropriate to be designated
