

**BRECKLAND DISTRICT COUNCIL (OFF-STREET PARKING PLACES)
(AMENDMENT NO. 1) ORDER 2022**

1. Breckland District Council (“the Council”) in exercise of their powers under sections 32, 35 and 38 and with the consent of Norfolk County Council under section 39 of the Road Traffic Regulation Act 1984, the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order.
2. This Order is supplemental to the Breckland District Council (Off-Street Parking Places) Order 2014 (“the Original Order”).
3. This Order shall come into operation on 21 March 2022 and shall be cited as the Breckland District Council (Off-Street Parking Places) (Amendment no. 1) Order 2022.
4. Definitions set out in the Original Order shall apply in this Order,
5. The Breckland District Council (Off-Street Parking Places) Order 2014 is hereby amended as follows:

PART I – GENERAL

In Article 2 (Interpretation) the following definitions shall be added:

“Expiry Time”	means the time shown on a Parking Ticket as the time at which the waiting authorised by that Parking Ticket on the date shown on that Parking Ticket expires
“No Return Period”	means the period of time expressed (where applicable) in hours after the Expiry Time in column 6 of the Schedules during which a vehicle which has been waiting in a Parking Place (Limited) is not permitted to return to that Parking Place (Limited)
“Parking Place (Limited)”	means Parking Place no. 3 (Queens Square, Attleborough) where waiting is limited during the periods detailed in column 6 of Schedule 1 to this Order
“Relevant Position”	means exhibited on the dashboard or fascia of the vehicle or where the vehicle is not fitted with a dashboard or fascia in a conspicuous position on the vehicle
“Parking Ticket”	means a ticket issued by means of a Ticket Machine which indicates the date and time at which a vehicle entered a Parking Place and the Expiry Time
“Ticket Machine”	means any apparatus or device that issues Parking Tickets

PART II – DESIGNATION, AND PENALTY CHARGES

1. Article 8 shall be renumbered Article 8(1)
2. Articles 8(2) to 8(9) shall be added as follows:

"Parking Places (Limited)

- 8(2) The Driver of any vehicle authorised by this Order to park in any Parking Place (Limited) where a Ticket Machine is provided by the Council shall, upon parking in that Parking Place (Limited), immediately obtain a Parking Ticket from the Ticket Machine and display that Parking Ticket in a Relevant Position on the vehicle in respect of which it was issued so that the front of the Parking Ticket showing the Expiry Time is clearly visible from the front of the vehicle
- 8(3) A Parking Ticket is not transferable from one Parking Place (Limited) to another or from one vehicle to another
- 8(4) If at any time a vehicle is left in a Parking Place (Limited) where a Ticket Machine is provided by the Council and (subject to Article 8(8)) no Parking Ticket is displayed in the Relevant Position on that vehicle, then that vehicle shall be deemed to be parked contrary to the terms of this Order and shall be subject to the penalty provisions within this Order.
- 8(5) If at any time a vehicle is left in a Parking Place (Limited) where a Ticket Machine is provided by the Council and the Expiry Time as shown on the Parking Ticket issued for that vehicle has expired (or where Article 8(8) relates the maximum period for which that vehicle may wait (as detailed in column 6 of the Schedules to this Order) has expired) then that vehicle shall be deemed to be parked contrary to the terms of this Order and shall be subject to the penalty provisions within this Order.
- 8(6) If at any time a vehicle leaves a Parking Place (Limited) and returns to that Parking Place (Limited) within the No Return Period that relates to that vehicle that vehicle shall be deemed to be parked contrary to the terms of this Order and shall be subject to the penalty provisions within this Order.
- 8(7) If at any time when a vehicle is left during a period of waiting on the Days of Operation of a Parking Place (Limited) (as detailed in column 4 of the Schedules to this Order) and on the nearest Ticket Machine in that Parking Place (Limited) there is a notice placed by any person duly authorised by the Council indicating that the Ticket Machine is out of order then a Parking Ticket shall be obtained from another machine within that Parking Place (Limited) (where provided)
- 8(8) Where no valid Parking Ticket can be obtained as a result of all the Ticket Machines in a Parking Place (Limited) being designated as out of order in accordance with Article 8(7) above then vehicles may be left in the Parking Place (Limited) but for no longer than the maximum period for which that vehicle may wait (as detailed in column 6 of the Schedules to this Order)

Disabled Person's Vehicles

8(9) Article 8(1) (additional 30 minutes for Disabled Person's Vehicles displaying valid Disabled Person's Badge and Parking Disc) shall not apply to any Parking Place (Limited)"

SCHEDULE 1

Columns 4, 5 and 6 of Schedule 1 as it relates to Parking Place no. 3 (Queens Square Car Park Attleborough) shall be amended to read as follows:

4. Days of Operation of Parking Place	5. Hours of Operation of Parking Place	6. Maximum period for which vehicles may wait
Monday, Tuesday, Wednesday, Friday and Saturday	0800 hrs to 1800 hrs	waiting limited to 3 hours with no return within 1 hour from the Expiry Time
	1800 hrs to 0800 hrs	waiting unlimited
Sundays	At All times	waiting unlimited
Thursday (Bays which are clearly marked and designated for use by Market Traders)	1400 hrs to midnight	waiting unlimited within the operational period
Thursday (Bays which have no marking)	0800 hrs to 1800 hrs	waiting limited to 3 hours with no return within 1 hour from the Expiry Time
	1800 hrs to 0800 hrs	waiting unlimited
