BRECKLAND LOCAL PLAN – CORRESPONDENCE SENT IN ERROR
Examination of the Breckland District Local Plan (2011 – 2036) (the Local Plan)

I refer to my previous letter of 24th January 2018 regarding the examination of the Breckland Local Plan. I am writing to apologise as this letter was sent in error to everyone on our database. The letter should only have been sent to those who made representations on the Breckland Local Plan Pre-Submission Publication during the consultation held from 21 August 2017 to 2 October 2017.

The Town and Country Planning (Local Planning) (England) Regulations 2012 specifies under Regulation 20 and Regulation 24, that only those who made a representation about the local plan, which the local planning authority propose to submit to the Secretary of State, i.e. the Pre-Submission Publication, have the opportunity to partake in the local plan examination. Our records show that you did not make a representation during the Breckland Local Plan Pre-Submission Publication consultation held from 21st August 2017 to 2nd October 2017. It is therefore not possible to invite you to take part in the local plan examination, or submit further representations. I sincerely apologise for this error.

You were contacted in error as you have either made a representation at an earlier consultation stage of the local plan or asked to be notified about key stages of development of the local plan. Any representations made at earlier stages will have been taken into account in developing the local plan as detailed in the Council's Consultation Statement (LP/S/14). If you do not wish to receive such notifications in future, please email planningpolicyteam@breckland.gov.uk requesting removal of your details from our contact database.
